The strategy can be utilized as a good enhancement to fixed income allocation. The 90-day gross yield of the portfolio is 4.75% as of 10/31/2014.

The [Julex Dynamic Multi-Asset Strategy](#) is a multi asset class GTAA strategy that seeks to achieve better returns than a moderate global asset allocation portfolio with lower volatility and lower peak-to-trough drawdowns. The multi asset class strategy can include ETP investments in U.S. and international
